
**E-TENDER NOTICE**

On behalf of the Secretary ICAR the Director NRCE, Sirsa Road, Hisar invites online bids from eligible bidders/parties/firms for **Laser Leveling** of approximate 65 Acre Fields in Agriculture Farm, NRCE, Hisar on **F.O.R. basis** as per the enclosed terms and conditions. Laser Leveling should be carried out in the month of November and December 2018. 2. The interested firms will submit separate Technical and Financial bids through E-Tendering. An EMD Rs 30000-00 and Tender Cost Rs 1000-00 of appropriate amount in the form of a demand draft favouring Director, NRCE, Hisar should reach this office by 08-11-2018 upto 3.00 PM through Speed Post Or By Hand in shape of Demand Draft/Bank Guarantee. EMD and Tender Cost received late or without Tender Fee, EMD will be rejected.

3. The firms are required to upload copies of the following documents:-

- a) Scanned copy of Earnest Money Deposit (EMD)/ its exemption, if any.
- b) Scanned copy of Firm's registration, PAN Card, GST No., Tender acceptance letter.
- c) Scanned copy of Income Tax Statement for the last three consecutive financial years.
- d) Scanned copy of an undertaking stating that if the information/declaration/scanned documents furnished in respect of eligibility criteria are found to be wrong or misleading at any stage, the firm will be liable to punitive action.
- e) Please state whether business dealings with you presently stand banned by any Government organization; and, if so, furnish relevant details.
