The period of five years should be completed on the date of notification of calling of applications.</p> <p>For single ladies a minimum period of three years (including two years of probation period on initial appointment) will be applicable before applying for transfer. (If applied on Medical/ Working Spouse Grounds/ Single lady ground necessary certificate should be enclosed.</p>
