- 2. Atleast five applicants may be shortlisted based on their qualifying academic performance as per an assessment criterion. These shortlisted candidates will undergo a panel interview. For specialised jobs related to administrative/finance/legal positions, if necessary, written tests and assignments may also be conducted before the panel interview. In case of tie at any stage all the candidates who have same marks will be considered to have qualified for further rounds.
- 3. The appointment of selected candidate will be subject to the condition that he/she is declared medically fit for service by the prescribed medical authority.
