



**Terms and Conditions for rent/lease of space for running of Canteen Services**

1. There shall be a Canteen Management Committee (CMC) to select the canteen operator by evaluating performance & competence.
2. The contract shall be valid initially for one year from the date of signing of the contract and can be extended based on the performance reviewed by CMC.
3. The operator shall be required to deposit Performance Security money of Rs.1000/-, which shall be refunded to the operator upon successful completion of the contract period and upon handing over of the canteen rooms in order.
4. The canteen operator shall maintain regular cleanliness, hygiene, sanitation. Good quality and fresh food shall be served.
5. The operator shall arrange his/her own required good quality crockery consisting of plates, glasses, forks, spoons, cups, saucers and serving dishes, gas stove, containers for cooking, refrigerator, etc to run the canteen.
6. The operator cannot open sublet in part or whole without prior written consent of the Competent Authority and shall not use the space for the purpose of storing any other goods, apart from what is required for the canteen.
7. The operator shall operate the canteen daily on weekdays from 9:00 am to 6:00 pm. The operator shall make services available on request at any time of the day during weekdays and holidays.
8. The operator or employees of the canteen shall not setup residences within the premises of the Canteen or Centre.
9. The canteen operator shall submit the range of food items including packed food items and soft drinks to be served and their prices for approval by the Canteen Management Committee (CMC).
10. Sale of food items on credit shall be at the discretion of the operator. The CMC shall not be responsible for collection of any dues.
11. Sale of cigarettes and alcohol including beer is strictly prohibited in the Canteen.
12. The operator shall provide identity of the employees for security reasons.
13. The property of the Centre in the canteen shall be maintained properly and any cost of loss or damage shall be borne by the operator.
14. The Centre shall not pay any compensation in respect of any injury or death caused to the workers of the Operator. It will be the sole responsibility of the Operator under the applicable law/ rules.

A handwritten signature in blue ink is located at the bottom right of the page, with the date '17/5/23' written below it.

15. If the operator encounters any problem, it shall be submitted in writing to the CMC.
16. The Centre shall terminate the contract as well as security money with immediate effect on any of the following grounds:
  - 16.1 Failure to comply with any of the above terms and conditions
  - 16.2 Failure to comply with the quality, price and sanitation standards
  - 16.3 Instance of any potential threat to the security, peace and harmony and
  - 16.4 Written complaint from the clients of the service centre with regard to quality, price, sanitation, services and any other canteen related issues.
17. If either of the parties wishes to terminate the contract prematurely, such termination of contract shall be done with an advance written notice of a **minimum period of two month of such intention.**
18. INTERPRETATION OF TERMS AND CONDITIONS: The Centre/Canteen Management Committee shall be final authority regarding interpretation of any or all of the terms and conditions in the event it is necessary.
19. The COMPETENT AUTHORITY of NRCE, Hisar reserves the right to award or cancel the order at any time without assigning any reason.
