- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. - 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. Technical Specifications of Microplate Reader

- 1. A spectral scanning unit for UV-visible wavelength range, with cuvette port (with no extra attachments) and should be able to read 6 to 384 microwell plate format and micro volume plate format to read many low volume samples at a time.
- 2. The instrument should have a large number of in built protocols in stand-alone mode.
- 3. Should work as a standalone system in absence of computer and also able to run with computer controlled software.
- 4. Analysis software should be supplied with unlimited user license.
- 5. Should be suitable for performing end point studies, kinetic studies, spectral scanning studies and different kinds of assays for nucleic acids, proteins, ELISA, cell culture, enzymes, microbial growth and cytotoxicity.
- 6. Instrument should include low volume microplate for low volume samples to be read many simultaneously.
- 7. System should have touch screen for quick usage.
- 8. At least two USB ports and provision be there for internet connectivity/printer connectivity in the equipment.
- 9. Instrument should be able to provide the wavelength range from 220 nm to 999 nm.
