- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Bid Security:- A Bid security declaration should be furnished by all the bidders (on company letter pad), if otherwise not exempted, stating that if I/We withdraw or modify the bid(s) during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of two year to submit bids with this office in future.
- 3. The Director, NRCE, Hisar reserves the right to accept or reject all or any of the bid in part or full without assigning any reason.

- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable shouldbe included in the quoted prices.

Technical Specifications of Ultrapure Water Purification System

- 1 The Complete Ultrapure Water system must give ASTM Type III pure and Type I ultrapure water from a single system with Tap water as the feed source.
- 2 Pre filter: It should come with integrated booster pump and should produce water that qualifies feed water requirement of the main system to ensure minimum recurring cost down the line. It should consist of water softener and should be customized based on feed Tap water quality test report.
- 3 Pre-filtration System: Three stage pre-treatment system with 10, 5 & 1 micron spun filters for removal of suspended particles and to take care of F.I. in water.
- 4 Preferred Water purification methods: Adsorption by means of spherical activated carbon, catalyst, reverse osmosis, ion exchange, optional UV irradiation, and end-position particle sterile filtration
- 5 The system should come with closed bag system of 5-8L inbuilt to store consistently high quality pure water for prolonged period and prevent Contamination by ambient air. Should have technology to avoid time consuming cleaning process as well as use of chemicals.
- 6 It should be a compact system capable of producing Ultra-Pure Water for molecular biology applications.
- 7 Microprocessor controlled Management Systems for continuous monitoring of water purity
- 8 Should produce Ultra-Pure water (Type- 1) from tap water for different applications

- 11 Should have R.O; D.I/purification pack; and double wavelength UV (185/254 nm) in a single unit
- 12 It should have an integrated / separately provided docking / storage vessel with 6-50 Liter capacity for storing the water
- 13 It should have recirculation facility to maintain consistent peak water purity.
- 14 It should have display for TOC & temperature, conductivity, volume dispensing, alarm and tank water level indicator.
- 15 The Life time of various membranes and consumables should be stated; Pretreatment cartridge, RO membrane, Deionization cartridge, UV lamp and PESU membrane.

- 16 System should have touch screen display with intuitive menu navigation facility for easy operation.
- 17 Re-circulation feature in standby mode to maintain the purity of the water.
- 18 The system may have the volume-controlled dispensing function from 50 ml to 5 l (in 50-mlincrements).
- 19 System should be Designed, Developed and Produced under DIN/ISO 9001 certificate Quality Management system.
- 20 Instrument should show water volume in reservoir graphically.
- 21 It should have cartridge change indicator.
- 22 The production rate of the unit should be minimum 3L/Hr. and the dispense rate should be minimum 1.0L/min.
- 23 The cost of one set of replacement consumables (cartridges) involved should be quoted.
- 24 Two years on-site warranty with 3 year annual maintenance contract.
