- Delivery: The firms have to collect the samples for sequencing from the indenting officer within 10-15 days of awarding the order in their name and the final results should be submitted within 2 months of receipt of samples from ICAR-NRCE, Hisar.
- The payment of said services is to be made on completion of satisfactory supply. The supplier will have to send bill in triplicate indicating clearly the purchase Order No. date and other details of supply, while quoting the rate(s) of items the following information invariable be made available.
  - I. Quotation shall remain valid for acceptance or a period of not less than 90 days after the specified date of opening of the order.
  - II. The firms on whom the supply order is placed within the period of acceptance of the offer will be required to execute the supply within a specified period from the date of issue of the supply order. #### Specification for Whole genome Sequencing

- 1. Host and virus: Swinepox virus (DNA virus) cultured in pig kidney cells (PK-15 cells). The firm has to collect samples from ICAR-NRCE, Hisar using dry ice/proper cold condition
- 2. Type of sample: Inactivated virus suspension. Total DNA extracted from virus infected cells can also be given, however isolation of DNA at firm's end will be preferred to avoid the possibility of rejection of samples based on DNA quality.
- 3. Total no. of Samples: 6 samples for Whole genome Sequencing
- 4. Type of service: Whole genome sequencing and Bioinformatic analysis
- 5. Genomic DNA solation: Kits & protocols used for DNA Isolation are to be disclosed if DNA isolation carried out at firms end.
- 6. Quality Control Platforms: QC of the isolated DNA should be done on Agilent Bioanalyzer/Tapestation, Nanodrop/Qubit also provide Gel Picture (Mandatory if Bioanalyzer/Tapestation not available). DNA QC Analysis Report to be provided within 15 days of receipt of samples from laboratory.
- 7. Sequencing should be performed on Illumina Platform
- 8. Library Preparation and QC should be done using illumina recommended protocol
- 9. Read length: 150 Paired End for WGS
- 10. Read quality: > 90% HQ reads with Score >=Q30
- 11. Total reads: 4-5 Gb Raw data / Sample for WGS
- 12. The complete scope of work should be done by the vendor, having a sequencing facility set up, within India.
- 13. The vendor should provide certificates to testify the possession of an in-house sequencer based in India and capable of handling sequencing work. (Attach Proof of Installation).
