The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. - 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Director NRCE, Hisar invites on line bids through GeM portal from eligible bidders for Concentrate feed item as per specification, terms & conditions given below:

* Terms & conditions and specifications for the Concentrate Feed are as under:-

- 1. Interested eligible bidders are requested to submit their quotations through GeM portal alongwith all necessary documents as per terms and conditions of tender document. The quotation/tender letter is also available on Institutes website <u>http://www.nrce.gov.in</u>. The tender can be uploaded/submitted as per dates given on GeM portal.
- 2. Bid Security Declaration:- In place of EMD a Bid security declaration should be furnished by all the bidders (on company letter pad) stating that if I/We withdraw or modify the bid(s) during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of two year to submit bids with this office in future.
- 3. A supplier shall not submit more than one quotation for the same goods
- 4. The supply will be on FOR basis and rate quoted in INR.
- 5. No conditional tender will be accepted at any cost.
- 6. **Performance Security**: 3% of the total cost of supply as performance security money is to be deposited by the selected bidder before placing the supply order in form of DD/BG/FDR in favour of ICAR UNIT NRCE, Hisar.
- 7. Sample of the feed ingredients should be submitted to this office before the opening of tender/bid. No tender/bid will be accepted without sample.
- 8. **Payment:**The payment of goods is to be made on completion of satisfactory supply. The supplier will have to send supply challans and delivery notes along with the supply and bill in triplicate indicating clearly the purchase Order No. date and other details of supply, while quoting the rate(s) of items the following information invariable be made available.
- 9. Quantity can be increased or decreased as per our requirement.
- 10. All the disputes/litigation, if any will be subjected to Hisar jurisdiction only.
- 11. Director, NRCE, Hisar reserves the right to accept/reject any or all the tenders without assigning any reason.
- 12. The firms are required to upload copies of the following documents:

4. Terms and Conditions:

- The supply must be met FOR NRCE Godown, Hisar campus as per schedule (as above).
- The manufacturer should be an ISO Certified Indian firm manufacturing concentrate feed for equines as evidenced by product line or government office orders.
- The firm should have experience of supplying the concentrate feed to the government institutions and should enclose a supply order copy as evidence.
- The firm should be FSSAI certified and registered under MSME.
- The manufacturer should submit the quote along with sample of the concentrate feed to be supplied.
- At the time of supply the manufacturer will enclose quality analysis report of the finished concentrate feed from a certified laboratory.
- The finished product should be apparently free from any foul smell and mold/fungus.
- The finished concentrate feed should be packed in individual 50 kg new gunny/plastic bags (good quality) and sealed/stitched individually without any gaps.
