- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. - 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable should be included in the quoted prices.

Scope and Specifications of Mineral Mixture for Horses

I. Composition:

- a. The mineral mixture should be specifically formulated for use on horses only. And it should be clearly indicated on the product and brochure.
- b. The mineral mixture should have enough Macro minerals and at least must include calcium, phosphorus, sulphur. In addition to it the mineral mixture should also have trace mineral and at least must include iron, manganese, copper, iodine.
- c. The mineral mixture should also have enough Vitamin D3, Vitamin A, L-Lysine Hydrochloride, and D-biotin. Yeast culture Saccharomyces cerevisiae must also be included as probiotic.
- d. Feeding instructions and its bioavailability should be clearly indicated in the literature.
- e. The firm/brand and the products should be established in the Indian market.
- f. The finished mineral mixure should be uniformly blended and packed properly.

II. FOR delivery to NRCE store, Hisar.

III. Terms and Conditions:

- The manufacturer should be an ISO Certified Indian firm.
- Manufacturing firm should be registered under MSME for manufacturer of mineral mixture for animal species.
- The finished mineral mixture should be free from excess moisture contents, any foul smell, and molds.
- The product of the firm should be branded commercially and should enclose the brochure of the product.
- The firm should have experience of supplying the mineral mixture for horses to the government or other institutions and should enclosed a supply order copy along as a proof.
- Mineral Mixture should be in packing of 1 Kg.
