4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. **Scope of Work**

1. High Quality & high molecular weight DNA isolation from samples has to be done.
2. The quantity and quality of isolated DNA should be measured using a Nano Drop ND-1000 spectrophotometer (Thermo Fisher Scientific, Waltham, MA, USA) and PFGE gel electrophoresis, respectively.
3. Library preparation should be done using Illumina True-Seq PCR Free library.
4. Sequencing on Illumina MiSEQ at a read length of PAIRED-END(2x250 bases).
5. 3-4 GB high quality Q30 filtered data per sample should be generated.
6. Advanced Bioinformatics:
  - a. Read QC, trimming and Filtering.
  - b. Deconvolution of reads. identify subgroups in Read Clouds that largely corresponded to individual fragments of DNA.
  - c. Identify reads from a single linked fragment could be classified using any short read taxonomic classifier.
  - d. Assembly and re-assembly of unassembled reads using Athena assembler followed by scaffolding using LINKS.
  - e. Ab-initio Gene prediction.
  - f. Genome Annotation & Comparative Genomics.
  - g. SNP and In-Del calling.
  - h. An optional imputation of the variants can be done to impute missing data.
  - i. Phylogenomics analysis.
  - j. Analysis report containing complete methodology from Sample QC to Data analysis with all the Tables, Figures&Results. (MA-PLOT, Volcano plot, heatmaps).
  - k. Final data reporting.
