- 1. - 3. The Director, NRCE, Hisar reserves the right to accept or reject all or any of the bid in part or full without assigning any reason.

- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable shouldbe included in the quoted prices.

## **Technical Specification for CO<sub>2</sub> Incubator**

- 1. The CO<sub>2</sub> Incubator is required for incubation of microbiological samples.
- 2. Incubator should have a working volume of 160 L or above (air jacketed).
- 3. The Incubator should have LCD Touch Screen Controls and USB data logging facility for checking the previous performance of the incubator, including temperature, with a data storage facility of 7 days or more.
- 4. It should have a closed loop HEPA filter system.
- 5. The machine should have a display and control for temperature and carbon dioxide levels.
- 6. The machine should have an IR sensor.
- 7. It should have an air jacket system with microprocessor control.
- 8. The machine should have an superior quality inner chamber made up of 304L stainless steel.
- 9. The incubator should have a water pan with 2L capacity & field reversible inner door.
- 10. The machine should have a stackable facility for saving lab space.
- 11. The incubator should have a temperature range from ambient +5 to 55°C
- 12. The machine should have a Temp. Accuracy: ±0.1°C
- 13. The incubator should have a CO<sub>2</sub> Range-0.1 to 20%.
- 14. The machine interior should have rounded corners for easy cleaning and decontamination.
- 15. The Machine should have a Filtration System Closed loop HEPA filtered system.
- 16. It should have shelves numbering 4 or more.
- 17. Machine should be upgradable for future requirements like an external automatic Tank switch for switch over from one CO2 tank to another.
- 18. Power 230V, 50Hz.
- 19. Equipment must be UL listed and CE certified.
