Bid Security:- A Bid security declaration should be furnished by all the bidders (on company letter pad), if otherwise not exempted, stating that if I/We withdraw or modify the bid(s) during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of two year to submit bids with this office in future.
- 3. The Director, NRCE, Hisar reserves the right to accept or reject all or any of the bid in part or full without assigning any reason.

- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. - Custom analysis of mass spectrometry proteins (*Equus caballus*) Identification and annotation of protein profiles in the sample group, including differentially expressed proteins.
- Software and Databases to be Used for the Analysis: Multiple software applications (such as similarity search software like BLAST) will be employed for the analysis. Databases like UniProt and KEGG should be utilized for annotation purposes.
- Custom analysis with XXXX samples, XXXX groups, and XXXX comparisons.
- The analysis must be carried out using the latest software and the current version of the database, with the *Equus caballus* species as the background.
- The vendor/service provider should implement an open and free access software tool to customize the analysis of the target of interest.
- The pricing should remain the same regardless of the number of comparison groups.
- The protocol used should be supported by other publications and aligned with the standard workflow.
- The timeline for completing the project should be clearly defined and should not exceed 5 to 6 weeks.
