Bid Security:- A Bid security declaration should be furnished by all the bidders (on company letter pad), if otherwise not exempted, stating that if I/We withdraw or modify the bid(s) during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of two year to submit bids with this office in future.
- 3. The Director, NRCE, Hisar reserves the right to accept or reject all or any of the bid in part or full without assigning any reason.

- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable should be included in the quoted prices.

Scope of Work

- Number of planned samples for metabolites studies 30 Nos.
- Sample collection should be done using dry ice in multiple batches.
- Extraction of metabolites should be done using standard protocol and should be carried out using a combination of solvents to extract maximum metabolites.
- The data has to be acquired using advanced LCMS/MS system to capture maximum number of metabolites and not less than 5000 metabolites with more than 80 minutes run time in both mode negative and positive.
- Lipid and Amino acid metabolites should be captured and analyse separately.
- Company have to provide their Metabolomics Relevant publication in high impact international journal like nature (Impact Factor more than 15.) in which their work is being acknowledged.
- Data analysis should be carried out using appropriate software's to get meaningful information of the desired metabolites. Customised databases should also be included. More than 3 different data base should be included in analysis.
- Company should allow Lab visit and analysis training as well.
- The data should be acquired in both positive and negative polarities. Each sample should be run in duplicates or triplicates.
- For the detection of specific metabolites, multiple reaction monitoring approach should be adopted and samples should be compared with a calibration curve.
- Data normalization should be done before calculating differential abundance of metabolites across the samples. Mass spectrometry data analysis should be carried out to identify metabolites by searching against custom and global databases for making meaningful interpretation.
- Heatmap, density curve, foldchange expression, volcano plot, Circos plot, Differential regulation of metabolites, PCA plot etc should be provide with the complete analysis report.
- Online data and report should be presented to the client after the completion of the project.
- Payment will be made after complete satisfaction of results.
- Company should promise for repeating of samples free of cost if not got satisfactory data.
