- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, Data should be generated within three weeks after the library QC. Complete project should be done within 30 days after the receipt of the sample.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable should be included in the quoted prices.
- 6. Complete descriptions, specifications and make of all the goods/items quoted should be given. Printed literature/pamphlets should be sent with the bid, failing which the same may not be considered.
- 7. The purchaser will evaluate and compare the bid which are substantially responsive i.e. which are properly prepared and signed and meet the required terms and conditions, specifications etc. The purchaser will award the contract to the supplier whose quotation will be determined to be responsive and offers the best evaluated price.

#### Scope of Work for Whole Genome Sequencing

- **1.** Technology required for sequencing: Illumina NovaSeq 6000.
- 2. No of Samples: 04
- **3.** Starting Material: We will give fresh tissues samples as starting material. Company should arrange the pickup of samples in two lots using dry ice.
- 4. Quality check of gDNA should be provided using gel, nanodrop & qubit.
  - QC of DNA will be done within 2 days after the shipment of the samples.
- **5.** Standard library preparation kits should be used for library preparation. Tape station profile of all the samples should be provided.
  - Library preparation report will be shared within 4 days after the sample QC. Detailed Tapestation/ Bioanalyzer profile should be shared.
- 6. Data required per sample: 10 Gb Q30 reads per sample.
  - Data should be generated withing three weeks after the library QC. Complete project should be done within 30 days after the receipt of the sample.
- **7.** Read length for sequencing should be 2x150 bp.
- **8.** Detailed report for each step should be provided by the company.
- 9. Bioinformatics support should be provided till paper publication and data submission in NCBI.
  - Primary data analysis including data quality check, filtering and trimming.
  - Data stats like coverage, N, poor quality reads etc.
  - Alignment stats (Alignment should not be less than 80 90%).
  - Whole genome assembly genome should be assembled in lesser contigs, preferable 1 -2 contigs.
  - Variant calling & filtering.
  - Assembly assessment.
  - Quantitative analysis.
  - Annotation using different databases.
  - Pathways Analysis.
  - Detailed analysis report should be provided for each step.
  - Company should allow the scientist to visit the lab any time during the experiment and analysis. Local data analysis support will be preferable.
  - Company must provide the support till manuscript submission. Queries raised by reviewer should be addressed immediately.
  - Confidential agreement should be signed before the start of the experiment.
