Bid Security:- A Bid security declaration should be furnished by all the bidders (on company letter pad), if otherwise not exempted, stating that if I/We withdraw or modify the bid(s) during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of two year to submit bids with this office in future.
- 3. The Director, NRCE, Hisar reserves the right to accept or reject all or any of the bid in part or full without assigning any reason.

- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. Label-Free Quantification Protein Analysis with Acetyl Enrichment

Objectives:

Quantitative Analysis:

Perform Label-Free Quantification (LFQ) of proteins in the sample.

Investigate differential protein expression between experimental conditions.

Acetyl Enrichment:

Enrich proteins for acetylation sites.

Identify and quantify acetylated peptides.

Data Integration:

Integrate LFQ data with acetyl enrichment data for a comprehensive analysis.

Methodologies:

Instrument: Synapt G2 QTOF LC MS/MS Mass Spectrometry (Waters)

Sample Preparation:

Extract proteins from biological samples using appropriate methods.

Quantify protein concentration and normalize samples.

Acetyl Enrichment:

Enrich for acetylated peptides using immunoprecipitation or other relevant methods.

Prepare enriched samples for mass spectrometry analysis.

Label-Free Quantification (LFQ):

Employ mass spectrometry-based LFQ to quantify proteins in the samples.

Data Analysis:

Utilize suitable data analysis tools for LFQ data processing.

Utilize bioinformatics tools for the identification and quantification of proteins and acetylation sites. Apply statistical methods to identify differentially expressed proteins.
