4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. 1. Special Terms and Conditions for Tractor Procured through GeM

1. The tractors procured through GeM will now be available through Bid mode only.
2. Buyer's have the option of using PAC "Proprietary Article Certificate" mode of procurement through Bid.
3. Sellers (OEM) and their authorised resellers (channel Partners) those have been authorised by the OEM will only be allowed to participate in the bid.
4. The price quoted in the bid by the OEM, or their Authorised Reseller will include ex-showroom price of the tractor plus delivery charges up-to consignee location excluding Registration and Insurance.
5. The registration and Insurance of the Tractor needs to be done by the buyer at their own cost.
6. The contract can be awarded to OEM or their authorised reseller as per Bid process.
7. The OEM will be responsible for all the warranty obligations, and they may assign their authorised service dealer for getting the job done under their supervision and guidance.

4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable should be included in the quoted prices.
6. Complete descriptions, specifications and make of all the goods/items quoted should be given. Printed literature/pamphlets should be sent with the bid, failing which the same may not be considered.
7. Specification of tractor

1. **Engine:** Engine should be powerful enough so that the tractor can work well for hours without any stoppage and capable to pull heavy implements like; MB Plow, Rotavator, Disc Plow and Harrow.
2. **Horse Power:** It should not less than 50 HP range (between 50 to 55 HP ranges) and able to gives out more performance in comparison of any of its peers under the same HP range.
3. **Wheel Drive:** It should be with wheel drive not less than of 2250 mm wide to provide optimum support to the tractor.
4. **Gear System:** With facilities of forward and reverse gear system.
5. **Lifting Capacity:** Lifting capacity should be to lift up to 2000 kg and functional to lift heavy things and can be used at farm and on the roads as well while transporting goods.
6. **Engine Cylinder:** It should be not less than 4 cylinder engines.
7. **Steering:** It should have power steering which provides easy and precise control on the field for a longer period of time without any inconvenience.
8. **Brake System:** This tractor has an oil immersed brakes System that enables the tractor to apply sudden brakes with minimum shocks.
9. **Fuel Tank:** The fuel tank capacity should be around 60 L.
10. **Meter:** With digital meter.
11. **Clutch Type:** Double clutch system.
12. **Air filter:** Should be with Ideal air filters to ensure clean and efficient airflow.
