The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. - 2. Bid Security:- A Bid security declaration should be furnished by all the bidders (on company letter pad), if otherwise not exempted, stating that if I/We withdraw or modify the bid(s) during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of two year to submit bids with this office in future.
- 3. The Director, NRCE, Hisar reserves the right to accept or reject all or any of the bid in part or full without assigning any reason.

- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable shouldbe included in the quoted prices.

- II. Technical Specifications for Electroporator

- **1.** Faster sample handling simple one button operation: To set the voltage or choose a preset parameter and insert a cuvette.
- **2.** Fast and freely programmable- should have two program buttons allow storage and recall or most commonly used parameters, default setting: P1 1, 700V and P2 2, 500V.
- 3. Safe electronics and integrated electroporation chamber to eliminate voltage leaks and misuse.
- 4. Compact, space-saving design for east storage and transport.
- **5.** Easy, GLP-complaint documentation via USB port data from the experiments can be exported for documentation and analysis.
- 6. The instrument should be compatible for electroporation of bacterial and yeast strains.
- 7. Should have an integrated cuvette carrier with cuvette holder.
- 8. It should have a capacitor to that is discharged during electroporation using a resistor.
- 9. Easy to decontaminate.
- **10.** Intuitive use- the status information on the colored display to minimize errors.
- **11.** Input voltage: 100V-240V +- 10%, 50Hz-60Hz.
- 12. Output pulse from: Decaying exponential pulse form with RC time constant of 5ms.

- Electroporator must be useful for our application of transformation of bacteria, yeast or microorganisms and delivery of DNA, RNA, Proteins and other small molecules and should have electric pulse form of exponentially decreasing.
- Electroporator must have aresistor which automatically set resistance parameters for transformation application and have electric voltage range from 200 to 2500V.
- Electroporator must have time constant of nominal 5 ms for electric pulses and must have a capacitor which automatically sets capacitance parameters for transformation application and have Internal Electrodes and integrated cuvette holder for user safety.
- Electroporator must have electronic protective circuit to prevent electric arcs for user safety.
