- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Bikaner. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable shouldbe included in the quoted prices.
- 6. Complete descriptions, specifications and make of all the goods/items quoted should be given. Printed literature/pamphlets should be sent with the bid, failing which the same may not be considered.
- 7. - II. Scope of Work

Automatic cryo-freezer for cryopreservation of stallion semen

- Automatic freezer for stallion semen and should be made of either stainless steel or any other equally tough insulating material and should work with minimal consumption of liquid nitrogen and Electronic temperature control, digital temperature display, programmable start and end temperature which guarantees a well-defined freezing curve and therefore the production of high quality frozen stallion semen.
- The automatic freezer should be supplied with all the essential accessories like pressurized liquid nitrogen tank, hose pipe for connection, freezing racks, real-time temperature monitoring and essentials for recording the freezing curves, 6 different colours of straws' of minimum 500 straws of each colour etc.,
- The automatic freezer should have the capacity to freeze 1000-1500 medium straws and 2000-2500 mini straws at a time.
- Freezing racks assure sufficient gap between two straws and inner chamber of freezing chamber for optimal freezing and design that enables easy handling.
- > Should have the facility of instant LN2 vapourisation and uniform freezing conditions
- > Provision to monitor the real-time temperature of the straws inside the chamber
- Should be supplied with liquid nitrogen pressurized (1.5 -2.5 bar) tank fitted with special LN2 hose fitted with a relief valve tarred at 20-40 PSI
- Should have minimal variation of temperature curves of the individual straws due to the uniform gas flow through the freezing chamber
- Should be supplied with a software either in computer/ laptop for storing the freezing curves and data.
- Freezing conditions can be monitored in real time during the freezing process directly on the PC Screen, stored.
- Facility to connect to personal computer/tab/laptop using windows based software where unlimited number of freezing curves can be stored and controlled through computer
- Tension : 220-240 Volts
- Frequency : 50-60 Hz
- Power : 1500-2000 W
- Intensity : 12-16 A
- Heating rates : 0.01 °C/min to 10 °C/min '
- Cooling rates : -0.01 °C/min to -10 °C/min

1. Stainless Steel insulated freezing chamber

- Should be made of Stainless Steel and thermal insulated designed for optimal freezing of minimum 4-6 racks involving the freezing of either 200-250 medium Straws (0.5 ml) or 400-450 mini Straws (0.25 ml).
- The freezing racks assure sufficient gap between two straws and inner chamber of freezing chamber for optimal freezing and design that enables easy handling.
- Freezing Chamber should not be more that 650 mm X 400 mm X 550 mm and weight 35-40 kg.

- > Consumption of Liquid Nitrogen is not more than 5-8 liters fully loaded machine.
- > Should have Platinum coated temperature probes for the temperature
- Should have high-speed turbine to allow instant LN2 vaporization for optimum and uniform freezing conditions.
- Should have 2 High output-heating elements to heat the unit back to dry before next freezing cycle.
- Should be equipped with pair of K probes to measure the Straw temperature in real time. Or a PT 100 probes to measure the temperature of straws.
- LN2 solenoid valve piloted by control box with maximum size 370 mm X 380 mm X 170 mm with weight 8 Kg.

2. Liquid Nitrogen Pressurized Tank

- Minimum 50-60 L Pressurized Tank
- > Special LN2 hose fitted with relief valve tarred at 20-25 PSI.

3. Computer/Software and PLC

- > Facility to store different freezing curves with different segments
- Curves can be stored, edited and deleted easily from the regulator/controller by an easy system of touch buttons.
- Unit can be connected to personal computer using windows-based software where unlimited number of freezing curves can be stored and controlled through computer.
- Freezing conditions can be monitored in real time during the freezing process directly on the PC Screen, stored and later printed on the PC's printer.
- Display temperature of Semen and the freezing chamber in comparison to the theoretical freezing curve.
- At any time the PC can be connected or disconnected not affecting the work of this freezing unit.
- The supplying firm should have experience of installing successfully at least three such systems in CMU graded lab in India, for which necessary documents must be attached. The satisfactory working report from the user also should be attached.
- The manufacturing firm should have their training and services center in India to provide after sales services and all relevant details should be provided in tender.
- The Equipment must be quoted with all additional software's and one year warranty including onsite training & installation.
