1. The delivery of goods/equipment shall be F.O.R. **EPC, Bikaner**. The firm should clearly mention the delivery period, which normally should not be more than 30 days from the date of issue of order contract.
2. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable should be included in the quoted prices.

Scope of Work

Genetic diversity analysis of equine breeds (96 samples) using Equine 80K SNP array based on illumina iScan / GeneTitan platform with Complete bio-informatics analysis.

1. Genetic diversity analysis of equine breeds (96 samples) using Equine 80K SNP array based on illumina iScan /GeneTitan platform with standard protocol by a laboratory in India have its own equipment, facilities and experienced team to carry out the entire work within the country, for which necessary proof (a) installation report; (b) Bioinformatics team details; (c) company profile; (d) publications, should be submitted by the firm.
2. The firm should pick-up the DNA samples from ICAR-NRCE, RS-EPC, Bikaner and carryout the purification, if necessary. Should share the quality check report of the DNA samples, library and the raw data.
3. Quality control requirements: Genotyping results should have $\geq 95.5\%$ SNP call rate and $\geq 99\%$ reproducibility.
4. Raw data with details of filters applied and preliminary analysis of the results, including cluster analysis for SNP classification, internal control evaluation, called gender QC, pass thresholds for sample QC, SNP QC including call rate and MAF filters should be provided.
5. Data analysis should include:
 - Chip manifest file, Raw data obtain from Illumina iScan/GeneTitan platform
 - Genotype data in standard format and matrix for top and bottom strand.
 - Overall marker summary.
 - Genotype data in Heatmap format.
 - Filtered genotype data and summary at 0.05 MAF.
 - Zygosity Analysis, Kinship Analysis, Diversity Analysis, Linear Trees between the sample, PCA Analysis.
 - SNP marker phenotype association analysis for the provided performance data.
6. Genetic diversity analysis should include - Genetic distance within and between breeds, phylogeny, MAF, Individual assignment, inbreeding, population structure analysis, Population admixture analysis, Genome wide linkage disequilibrium analysis etc.
7. The firm should discuss the results and should carry out the bioinformatics analysis as per the requirement of the project and provide laboratory access to one researcher.
8. Raw data, analysed data report, complete report in presentable form, e.g., PDF, Word, Excel, Power Point format etc. should be provided. The images/ graphs/ diagrams/tables should be compatible with research publication formats.
