- 3. The Director, NRCE, Hisar reserves the right to accept or reject all or any of the bid in part or full without assigning any reason.

- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. Scope of the work

- 1. Number of planned samples for Proteome studies 40
- 2. Sample collection should be done using dry ice in multiple batches.
- 3. Extraction of Proteins should be done using standard protocol and should be carried out using a combination of solvents to extract maximum Proteins.
- 4. The data has to be acquired using advanced LCMS/MS/QTOF system to capture maximum number of Protein and not less than 2000 significant Protein with more than 60 minutes run time in both mode negative and positive
- 5. Secretomes molecules and Peptides molecules should be captured and analyse separately.
- 6. Company has to provide relevant publication in high impact international journal like nature (Impact Factor more than 15.) in which their work is being acknowledged.
- 7. Data analysis should be carried out using appropriate software's to get meaningful information of the desired Proteins. Customised databases should also be included. More than 3 different data base should be included in analysis.
- 8. Company should allow Lab visit and analysis training as well.
- 9. The data should be acquired in both positive and negative polarities. Each sample should be run in triplicates.
- 10. For the detection of specific Proteins, multiple reaction monitoring approach should be adopted and samples should be compared with a calibration curve.
- 11. Data normalization should be done before calculating differential abundance of Protein across the samples. Mass spectrometry data analysis should be carried out to identify Proteins and peptides by searching against custom and global databases for making meaningful interpretation.
- 12. Heatmap, density curve, foldchange expression, volcano plot, Circos plot.

 Differential regulation, PCA plot etc should be provide with the complete analysis report. " Online data and report should be presented to the client after the completion of the project
