If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer)of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 5. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Bid Security:- A Bid security declaration should be furnished by all the bidders (on company letter pad), if otherwise not exempted, stating that if I/We withdraw or modify the bid(s) during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of two year to submit bids with this office in future.
- 3. The Director, NRCE, Hisar reserves the right to accept or reject all or any of the bid in part or full without assigning any reason.

- 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
- 5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable shouldbe included in the quoted prices.
- 6. Complete descriptions, specifications and make of all the goods/items quoted should be given. Printed literature/pamphlets should be sent with the bid, failing which the same may not be considered.
- 7. The purchaser will evaluate and compare the bid which are substantially responsive i.e. which are properly prepared and signed and meet the required terms and conditions, specifications etc. The purchaser will award the contract to the supplier whose quotation will be determined to be responsive and offers the best evaluated price.
- 8. Successful quoter/bidder has to deposit 3% amount of the total cost of the equipment as Performance Security money in the form of DD/BG/FDR in favour of ICAR UNIT NRCE, Hisar etc.
- The payment of goods is to be made on completion of satisfactory supply and installation. The supplier will have to send supply challans and delivery notes along with the supply and bill in triplicate indicating clearly the purchase Order No. date and other details of supply.
  - I. Bid shall remain valid for acceptance for a period as indicated on GeM portal.
  - II. The firms on whom the supply order is placed within the period of acceptance of the offer will be required to execute the supply within a specified period from the date of issue of the supply order. If the supplier fails to delivery any or all of

goods, the purchaser shall have the right to make deductions as per liquidated damages clause. A sum equivalent to 0.5% of the delivery price of the delayed goods for each week of delay may be deducted. The maximum limit of such deduction will be of 10% of contract price. #### **SPECIFICATIONS FOR DUCTABLE AC**

- 1. The 5.5 Ton Ductable AC proposed to be procured should be of a reputed brand prevalent in the market having its Company's Authorised Service Centre at Hisar so as to get efficient and uninterrupted "after sale service" of the product after its procurement. A certificate to this effect indicating the name, address & authorization of the firm as "Service Centre" at Hisar should be attached by the bidding firms alongwith their bids failing which the bids shall not be accepted.
- 2. The firm supplying the unit will have to fix the unit at the site i.e. NCVTC Repository, ICAR-NRCE, Sirsa Road, Hisar alongwith complete installation of the unit including its ducting, ducting grill, copper pipe, insulation, ODU Stand for outdoor unit and all other accessories/electrical/civil work involved, if any for making the unit functional and as such rates should be quoted by all the firms inclusive of all these items. No extra payment than the quoted amount shall be paid to the firm/bidder for any of the extra work/item required for installation of the unit and the firm will have to make the unit fully functional to the complete satisfaction of the concerned incharge.
- 3. The firm(s) must first visit the site personally to see where the unit is to be installed and explore the feasibility whether duct of already available 11 Ton Ductable AC installed in the NCVTC Repository can be utilized and attached with the new 5.5 Ton Ductable AC (to be used as an alternate arrangement) without creating/fixing a new and separate duct for 5.5 Ton AC and should quote their rates accordingly.
