- 2. Sample collection should be done using dry ice in multiple batches.
- 3. Extraction of Proteins should be done using standard protocol and should be carried out using a combination of solvents to extract maximum Proteins.
- 4. The data has to be acquired using advanced LCMS/MS/QTOF system to capture maximum number of Protein and not less than 2000 significant Protein with more than 60 minutes run time in both mode negative and positive
- 5. Secretomes molecules and Peptides molecules should be captured and analyse separately.
- 6. Company has to provide relevant publication in high impact international journal in which their work is being acknowledged.
- 7. Data analysis should be carried out using appropriate software's to get meaningful information of the desired Proteins. Customised databases should also be included. More than 3 different data base should be included in analysis.
