For specialised jobs related to administrative/finance/legal positions, if necessary, written tests and assignments may also be conducted before the panel interview. - 3. The appointment of selected candidate will be subject to the condition that he/she is declared medically fit for service by the prescribed medical authority.

However, the candidate should bring hard copy of duly filled in application form alongwith CV and a passport size photo and other attested certificates at the time of interview, if found shortlisted and called for interview.
