- The candidates will send their applications at the given email address against the project so as to reach by **30.09.2024** positively. It is mandatory to enclose requisite Degree Certificate with the soft copy of application. Merely filling up marks in the application form will not be sufficient to short list the candidate for interview.
- At least five applicants shall be shortlisted based on their qualifying academic performance as per an assessment criterion. The date and time of Interview shall be informed to short listed candidates through the email address as given by the candidates. These shortlisted candidates will undergo a panel interview at ICAR-NRCE, Hisar.
- The appointment of selected candidate will be subject to the condition that he/she is declared medically fit for service by the prescribed medical authority.

4. There is no need to send hard copy of the application and only the applications received through email at the given email ID will be entertained. However, the candidate should bring hard copy of duly filled in application form along with CV and a passport size photo and other attested certificates at the time of interview, if found shortlisted and called for interview.
5. The applicants must bring with them the original documents along with experience certificate(s) if any, at the time of interview.
6. No TA/DA will be paid to the candidates for attending the interview.
7. Eligible candidates who are called for interview will be required to be present at least 30 minutes before scheduled time on the date of interview for completing necessary formalities.
8. Decision of the Director, ICAR-NRCE, will be final & binding in all aspects.
9. **Candidates are advised to keep visiting NRCE website for update, if any.**

Other Terms and Conditions

- I. The positions are purely temporary and will be filled on contractual basis till the termination of the project OR as per the need, whichever is earlier. The duration of engagement is given as against each. However, duration of engagement can be curtailed/extended as per need and subject to performance of the candidate.
- II. The engagement will not constitute a regular job or appointment of any nature in the ICAR/NRCE.
- III. **The minimum age under Young Professional category will be 21 years and maximum 45 years with relaxation as per rules.**
- IV. Concealing of facts or canvassing in any form will lead to disqualification of the candidate. The applicants are advised to report any misinformation to the office of Director, NRCE at dirnrce@gmail.com.
- V. The selected candidate will be stationed at ICAR-NRCE and NCVTC, Hisar and have to attend laboratory and field trials related works at this Centre.
- VI. Candidate should be willing to complete the allotted work in time. Work may be allotted based on the project requirements rather than the expertise of the candidate.
- VII. The working hours will be same as regular employees of ICAR. No extra benefit will be allowed for working beyond office hours. **Unauthorised absence from the project/work for a continuous period of 08 days without valid reasons shall lead to automatic termination of the engagement.**
- VIII. The Young Professionals shall have to comply with the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013.
- IX. The Young Professionals shall be subject to the laws of secrecy of the country and will sign a declaration of secrecy and Non-Disclosure Agreement before reporting (Annexure-II).
