If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. 5. - Comprehensive warranty**

Comprehensive warranty shall include preventive maintenance including calibration as per technical/ service /operational manual of the manufacturer, service charges and spares,. During the warranty period commencing from date of the successful completion of warranty period, Service personnel shall visit each consignee site as recommended in the manufacturers technical/ service /operational manual, at least once in six months. warranty shall not be including the consumables .Further there will be 98% uptime warranty during warranty period on 24 (hrs) X 7 (days) X 365 (days) basis, with penalty, to extend warranty period by double the downtime period.
 - Service centres**

Details of Service outlets in India to render services for equipment to be furnished to buyer/consignees with complete address ,telephone numbers, e mails etc at time of making the supplies .It shall be the responsibility of seller to ensure that authorized service centres are available to cater to the areas where supplies are made within reasonable distance from where the service calls can be handled .Details of toll free numbers for service call and online registration of service requests also to be provided buyer/consignee at the time of supplies.
 - Source of supply**

It shall be responsibility of seller to provide Documents regarding source of equipments such as copy of Performa invoice or any other documents to establish that the products supplied are manufactured by OEM indicated and sourced from them.
 - Packing and Marking**

Medical equipments being very delicate and sensitive packing for the goods should be strong and durable enough to withstand transit including transshipment (if any), rough handling, open storage etc. without any damage, deterioration etc. .The size, weights and volumes of the packing cases, remoteness of the final destination of the goods, availability or otherwise of transport and handling facilities at all points during transit up to final destination,. Quality of packing, the manner of marking within & outside the packages and provision of accompanying documentation shall take in to consideration the type of medical equipments being supplied. The accessories shall be suitably labelled and packed .Each of the package shall be marked on three sides with indelible paint of proper quality: indicating contract number and date , brief description of goods including quantity ,. Packing list reference number , country of origin of goods and any other relevant details.
 - Spare Parts**

Seller shall provide materials, information etc. pertaining to spare parts manufactured and supplied by the OEM . It shall be ensured that the required spares are available for purchase at least for 10 years from date of supplies .In case due to any reasons the production of the spare parts is discontinued sufficient advance notice should be given to the buyer/consignee before such discontinuation to provide adequate time to purchase the required spare parts etc. Further, OEM and their service centres/dealers shall carry sufficient inventories to assure ex-stock supply of consumables and spares for the equipments so that the same are available. OEM or reseller shall always accord most favoured client status to the buyer/consignee and shall give the most competitive price for spares and consumables of its machines/equipments supplied.
 - Installation, Training, Manuals**

Seller shall be responsible to carry out Installation & commissioning, Supervision and Demonstration of the goods. They shall provide required jigs and tools for assembly, minor civil works for the completion of the installation and Training of Consignees representatives for operating and maintaining the equipment and Supplying required number of operation & maintenance manual for the goods. In case the category parameters are specifying any

- requirements regarding the installations , training and manuals the same shall also be applicable.
- **Electrical safety checking**
Sellers are required to make sure that they furnish the list of equipments for carrying out routine and preventive maintenance to buyer/consignee. They should make sure to periodically check the electrical safety aspects as per BIS Safety Standards or equivalent .In case they do not have required equipment for such testing should ensure that the equipments checked for electrical safety compliance through labs with facilities for such checking during every preventive maintenance call.

Biosafety cabinet must maintain Class 3 conditions as per ISO norms and should contain 99.99% supply and exhaust efficient ULPA Filters. 7. Should have a HMI based Touchscreen control panel with display of airflow / air velocities in real time and also display other parameters like UV light on / off, white light on / off, UV and HEPA filter usage hours, remaining life of the filters / alarm for filter change etc. 8. The microprocessor controller must be located at an accessible position so as to help the user to view display parameters from a seated working position in front of the cabinet. 9. The cabinet should be essentially made of 304 stainless steel interior with curved edges t corners and epoxy-coated steel exteriors. 10. Must essentially have removable, seamless perforated work surface with lift out knobs and arm rests made of stainless steel. 11. The area beneath the work surface must be negatively pressurized to ensure that any contaminations are quickly trapped and drawn in to HEPA/ULPA filters. 12. Should essentially include a blower motor for simultaneously control of both in flow velocity (105 FPM /0.5m/sec) and down flow velocity (60 FPM / 0.3 m/ sec). 13. The cabinet must have smart system to automatically reduce fan/ blower motor speed to 30% when the front window sash is in closed position to ensure reduced energy consumption when the cabinet is not in use. 14. Glare- free Fluorescent lighting located outside the contaminated work area.\ 15. UV light fitted at appropriate position for disinfecting the work area of cabinet. UV light on / off control and lamp usage timer should be present in the control panel. 16. Front side of the cabinet should be made of a least ¼ “ thickness tempered safety glass inclined at 5⁰ and sash opening of less than 30 inches for providing access to work area. 17. The interior of the front glass must be accessible for cleaning without requiring the user remove or support the glass window. 18. Two electrical receptacles working on 220- volt models located on side of cabinet. 19. One LPG port present on the inner side walls of the cabinet. 20. The cabinet noise level must be less than 65 Db. 21. Machine should operate at single phase, 220 volts and 50 H_z. 22. Should have at least 50 installations of the same model in India 23. Warranty shall be one year on complete system. 24. Should be supplied with three 2 KVA online UPS with 30 min backup in the event of power failure. 	03
