4. The delivery of goods/equipment shall be F.O.R. ICAR-NRCE, EPC Bikaner. The firm should clearly mention the delivery period, which normally should not be more than 60 days from the date of issue of order contract.
5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. All duties, taxes etc. payable should be included in the quoted prices.

1. Service provider should perform Whole Transcriptome Sequencing using Illumina NovaSeq 6000 and Bioinformatics Analysis.
2. Total Number of samples: 24
3. The service provider should extract a high-quality RNA from the Tissue samples.
4. Service provider should ensure that the isolated RNA will undergo a comprehensive quality control assessment, encompassing evaluations using Qubit, Nanodrop, and Agilent Bioanalyzer techniques. Furthermore, a detailed RNA QC report will be furnished.
5. The service provider should do Ribozero depletion (rRNA depletion).
6. Library quality check should be done by the Qubit, Gel and Bioanalyzer.
7. Prepared libraries to be sequenced in Illumina NovaSeq 6000 using sequencing chemistry 2*150bp.
8. Service provider should generate High quality 20GB clean data per sample.
