Specification of Laboratory information Management System (LIMS) Specification for Laboratory Information Management System (LIMS) to be established at ICAR-NRCE Hisar

The National Research Centre on Equines is a premier institute established under the aegis of the Indian Council of Agricultural Research for researching equine health and production. The NRCE provides health facilities, and production and provides advisory and consultancy services and capacity development of equines. NRCE is providing disease diagnostic services to different stakeholders.

The NRCE requires an effective Laboratory information management system for equines as per its operational procedures. The requirements in terms of proposed application, hardware and software are furnished below:

The NRCE wishes to develop software system to manage the disease diagnosis related operations. The application should include:

1._Test request form Management

- 2. Sample approval
- 3. Order management
- 4. Client Portal
- 5. Laboratory Testing and Reporting
- 6. Report delivery via print, email, Whats App, SMS download
- 7. Online Payment using payment gateway and link
- 8. Account Management
- 9. MIS and summary reports
- 10. SMS and WhatsApp gateway link
- 11. Any other related miscellaneous application came to know during implementation of operation

A. Proposal for Laboratory Information Management System for NRCE Hisar

It is proposed to remodel its existing Laboratory Information Management System in digital form. This application should provide the web application on the server with the following modules

1. Test Request form

The test form received from clients to be filled by the user in the application. The request form should contain

i. animal demographics.

ii. client details

iii. disease requested or tests

After sample verification, the tests will be ordered by the laboratory in charge for registration.

2. Registration

This module should register samples and generate an order ID. This will record the test request form in the scanned document along with other communication. A unique animal identification number also to be generated by the system. The user can also insert its own Unique Animal Identification number. This will help to correlate and generate the history of all the tests conducted for the animal by the NRCE over time.

3. Test Order

The orders generated above should have Test codes and specimen details captured from the disease or test request. The specimen barcode ID needs to be created

4. Result reporting

A result reporting Option should contain options such as pending orders, completed orders, and partially completed orders using various colour schemes. The reporting doctor and technician details are stored in the result reporting data. The results can also be modified if required with the reason of modification. An effective audit trail will be maintained for quality control

purposes. The application should have features required or NABLaccreditation. The application will ave the option of masking confidential data from laboratory technicians and other users. This will be done using user security modules.

5. Test Result Delivery Procedure

System should generate test reports and will send reports to clients in PDF format. These will be printed or sent as email, WhatsApP or an SMS link A download application will also help the clients download the reports directly from this proposed NRCE LIMS application website

6. MIS and summaries

This module should generate summaries and MIS reports in Excel sheets or PDF formats as per requirement.

7. Payment Gateway

A Payment gateway link should be provided for taking payments from clients sending the samples.

8. Security module

This should be a user creation and security module. This module will help addition to users, their operational securities for using the application, effective password and login Options.

9. Audit trail

The system should maintain all the activities of record creation, modification and deletion in the system. The application administrator can check user-wise periodic operations carried out, Any unauthorised activity will be monitored via this application.

10. SMS email and WhatsApp management

This will help in creating personalised SMS, emails a and WhatsApP messages in the application. A list of all delivered and undelivered messages to be maintained in this application.

11. Account receivable and payables

It is a module of client accounting. It should keep a complete ledger of all the clients with details of bills and receipts Users can also insert Journal accounting activities.

- 2. Fee and charges should be mentioned for Annual Maintenance for three years after the warranty period.
