Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. - 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 365 days from the date of issue of order contract.

Specification of Electroporator

- 1. The electroporator equipment should enable fast and efficient delivery of foreign materials into wide range of mammalian cell types including primary cells, stem cells and difficult-to-transfect cells
- 2. Equipment should allow efficient transfection of DNA, RNA and protein (viz. plasmid DNA, siRNA, shRNA, miRNA, CRISPR-RNP, peptides etc.) in commonly used mammalian cell lines, primary cells, stem cells, blood derived cells, endothelial cells, epithelial cells etc.
- 3. Equipment should have flexibility of transfection of samples with the range of 1x104 to 1x107 cells (varies by cell type) in small (10 µL) as well as large (100 µL) volume capacity without compromising viability of cells.
- 4. System should provide high transfection efficiency as well as cell viability (desired for both minimum ≥70%)
- 5. System should have biologically compatible pipette-tip chamber preferably with Clip Tip technology with electrodes which generate a more uniform electric field resulting in greater cell survival and low toxicity as compared to cuvette-based transfection.
- 6. The equipment should have output voltage range 0.5-2.5 kV, maximum power 300W, operating electrical requirements: 100-230 VAC, 50-60Hz
- 7. Equipment should have configurable transfection parameters enabling optimized conditions and also should have internal memory to store upto 10,000 protocols.
- 8. The equipment should have a large touch-screen display for user-friendly operation, should be compact enough to operate inside cell culture hood under sterile conditions
- 9. Equipment should work with single buffer kit for all kind of cell types and it should have longer shelf-life
- 10. The manufacturer should provide validated data for a wide range of cell types which can be used as reference
- 11. The system should be a CE certified
- 12. Provide with 2.0KV stabilizer
