OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

### 2. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

### 3. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

The bidders are required to provide the following documentary proofs with their bids as per the terms and conditions given below:

1. Service providers should have a registered office at the State of consignee location. Valid documentary proof (latest electricity/telephone bill/PAN card/GST no./Rent agreement) should be attached with the bid.
2. Bid Security: - An EMD @ 5% of bid estimated cost should be submitted by all the bidders, if otherwise not exempted, in the form of demand draft/BG drawn in favour of **ICAR UNIT NRCE** payable at **HISAR** from any Nationalized Bank. **The particulars of the EMD with details (bid no. & date)** should reach this office within 5 days of the closing date/time of GeM bid, **failing which technical bid will not be considered for technical evaluation**. Bidders who are exempted under EMD, are required to furnish a bid security declaration (on company letter pad) stating that if I/We withdraw or modify the bid(s) during the period of validity or if they are awarded the contract and they fail to sign the contract or to submit a performance security before the deadline defined in the request for bids document, they will be suspended for the period of two years to submit bids with this office in future, **failing which technical bid will not be considered for technical evaluation**.
3. MSME registration of firms should be as per the relevant category of services required.
4. Last three year continuous experience of the firm in the field of providing such services in Central Govt. establishments/Autonomous bodies/Corporations/reputed public funded organizations, if otherwise not exempted. Bidders will have to provide details in tabular form, alongwith documentary proofs of such experience.
5. Certified Balance Sheet of the firm for last three years signed/issued by the chartered accountant, if otherwise not exempted. Average Minimum turnover during the last three financial years of the firm should be Rs. 1.54 crores in book of account for such work/services, if otherwise not exempted.
6. EPF registration certificate issued by appropriate authority.
7. ESI registration certificate issued by appropriate authority.
8. The contractor/agency must have a registration under the Contract Labour (Regulation and Abolition) Act, 1970. The contractor shall obtain the labour license under this Act.
9. GST registration certificate issued by the appropriate authority.
10. Bidders are required to quote minimum service charge @ 3.85%. Bids quoted below the minimum service charge on as proposed by GeM will not be considered.
11. Bidders are required to submit an undertaking on company letter pad duly attested by NOTARY, as per following format:

Documents as per ATC uploaded/submitted in any other column will not be considered and their technical bids will be rejected straightway.

## Disclaimer/अस्वीकरण
