Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. 4. The delivery of goods/equipment shall be F.O.R. NRCE, Hisar. The firm should clearly mention the delivery period, which normally should not be more than 45 days from the date of issue of order contract.
5. Bid should be inclusive of all packing and other forwarding expenses, freight insurance charges. The firms should give the rates of items per unit also. The prices quoted shall remain firm & fixed during their currency of the contract. The rates and prices quoted shall be in Indian rupees only. - **Nosepiece:** Sextuple revolving nosepiece with DIC prism slot to accommodate 6 objectives at a time.
- **Stage:** Attachable mechanical stage with universal holder to accept all types of specimen holders and Pair of ring holder.
- **Illumination:** High intensity uniform brightness distribution scientific Grade LED (25-30W power consumption) cool white light, with life time of 50,000 hrs. or more.

Suitable C mount with relay lens should be provided. Camera should be capable to capture BF/PH/DIC/Fluorescence images. Microscope, Objective, LED fluorescence, camera and software should be from same manufacturer. Camera should provide with imaging acquisition software.

- Should provide certification of ISO, USFDA enlistment, EMC Directive (2014/30/EU), RoHS Directive (2011/65/EU) confirmation certificate.
- Should provide user list of at least 20 during last 3-5 years
- Research paper related to the use of the equipment should be provided with website link
- Compliance statement should be provided
- Should be provided minimum of 2 years warranty
